He is “permanent guest” at the Centre Virchow-Villermé (Paris-Descartes/Berlin-La Charité), and sits at the Transmissible Diseases Committee of the Haut Conseil de la santé publique (France).

Phillips and D. Killingray (eds), *The Spanish Flu Pandemic in 1918. New perspectives* (Routledge, 2003).

He co-authored with Lion Murard *L'Hygiène dans la République. La santé publique en France ou l'utopie contrariée, 1870-1918* (Fayard, 1996), and with Susan Gross Solomon and Lion Murard, *Shifting Boundaries of Public Health: Europe in the Twentieth Century* (the Press of the University of Rochester, 2008, paperback edition April 2013). His latest book, *Tempêtes microbiennes. Essai sur la politique de sécurité sanitaire dans le monde transatlantique* came out in 2013 (Gallimard).

Gino Fornaciari

He was, until 2015, Professor of History of Medicine at Medical School and Director of the Division of Paleopathology at Pisa University. At present he is Professor of Paleopathology and Funeral Archaeology at University of Pisa. His research activities regard mummies, paleonutrition and ancient bacteria and viruses. Prof. Fornaciari utilized different modern biomedical techniques (TEM, immunohistochemistry and aDNA) to study Italian, Peruvian and Egyptian mummies: in 1986, smallpox virus in 16th century Italian mummy; in 1989, syphilitic treponemes in Italian mummy of the same age; in 1992, the first discovery at EM of *Trypanosoma cruzi* in pre-Columbian mummy; in 1996, K-ras mutation in the cancer of Ferrante I of Aragon, a king of Naples of 15th century; in 2003, Human Papilloma Virus (HPV) in 16th century Italian mummy; in 2004, digitalis poisoning in the mummy of Cangrande della Scala, lord of Verona (1291-1329); in 2009, *Plasmodium falciparum*, cause of pernicious malaria in Medici of Florence, and in 2015 he studied by metagenomics the complete microbiome of a pre-Columbian mummy of 1000 years ago, revealing resistance to antibiotics. Prof. Fornaciari is author of more than 600 articles, prevalently of paleopathology and bioarchaeology, on important international journals and of some books and monographs.
